Terms and Conditions

This document contains the Terms and Conditions under which the West Australian Football Commission (ABN 51 167 923 136) (Promoter) will offer rewards under its *2023 WA Football Volunteer of the Year (Competition)*.

The Program commences at 9:00am (WST) on Monday 15 May 2022 and concludes at 11:59pm (WST) on Friday 14th July 2023 (**Competition Period**).

You can nominate any person or persons who have undertaken paid or volunteer service at their local football club.

A paid volunteer is classified as an individual who has received a small honorarium, totalling no more than what is outlined in the WA Football community football rules and regulations. You can nominate them by following www.thankavolunteer.com.au

The nominee (Entrants) must have demonstrated the below merits:

- a) Must have given notable voluntary service to Australian Football.
- b) Must be an ambassador for the game of football who acts and works for the best interest of the game, never bringing the game into disrepute.

When nominating, the nominator must outline what the nominee has demonstrated in regards to the following:

- Have undertaken paid or volunteer service at their local football club
- Gone above and beyond at their local football club to make it a better place

The nominator must select an award category outlined in the nomination form.

There will be 17 finalists, 1 from each WA Football District and Region, announced in The Sunday Times and through the WA Football Commission.

Nominations received via the www.thankavolunteer.com.au website during the **Competition Period** will also be eligible for the national AFL volunteer competition and the prize pool associated to this competition. Prize

In this program, commencing at 9:00am (WST) on Monday 15th May 2023 and concluding at 11:59pm (WST) on Friday 14th July 2023, the finalists will be announced on Sunday 27th August 2022. Whilst the overall winner will be announced at the 2023 Sandover Medal tentatively booked for Monday 25th September 2022. If the 2022 Sandover Medal is cancelled due to unforeseen circumstances the winner will be announced via WA Football digital platforms on Monday 25 September 2022.

The overall winner will receive a prize to the value of \$4,000. The prize is determined by the promoter and will be no less than \$4,000.

The overall prize is non-transferable and must be used by the winner of the 2023 WA Football Volunteer of the Year. The overall prize cannot be transferred for that of equivalent value and cannot be redeemed for cash.

General Terms

The Finalists will be notified through email or phone by a West Australian Football Commission official employee.

Finalists must supply the WA Football Commission with a valid postal address, email address, phone number and photo once told of their prize.

The warranty on the goods and services obtained as a result of the Competition remains the sole responsibility of the supplier/service provider of the Prize.

The Promoter reserves the right, at its sole discretion, to cancel, terminate, modify, extend or suspend the Competition at any time without notice.

By participating in this promotion Entrants agree to the Promoter using and disclosing the Entrant's personal information for the purposes of conducting the promotion, redeeming the Prizes and any other matter connected to or incidental to this promotion.
